#### 33/2009 ISABEL BELLAMY RURAL HOUSING ENABLER

The Parish Council welcomed Isabel back to give feedback on the Affordable Housing Survey. 171 forms were returned which is 32%, very good. Coming out of the survey was that 28 households were in need of housing, the report focuses on these 28. The top need was the 25-40 age range and then 16-25 age range. A lot of questions were asked about the proposed housing development at Lumsdale, in which DDDC had not set aside any affordable housing.

The next step is to walk around Tansley with a planning officer to try and point out any possible areas of land, but even then it is down to landowner to want to sell the land. This needs to be done in the next few weeks, due to light failure. Isabel would liase direct with the Councillors.

The clerk would chase up a reply from the objections put in regarding the development at Lumsdale.

The Council thanked Isabel for her attendance. The letter from High Peak Borough Council was received.

## 34/2009 VILLAGE HALL UPDATE

A letter has been received from the Tansley Village Hall Committee requesting financial support from the Parish Council. A discussion took place regarding the modernisation and repair of the village hall arising out of the above request. The Parish Council is mindful that the village plan survey carried out two years ago showed that 90% of the village saw that the retention and modernisation of the village is a priority.

## **RESOLVED:**

To inform the Village Hall Committee that the Parish Council will earmark and set aside in its Capital A/C a sum of £10,000 including the sum of £1,835 already allocated, Minute No 106/08 refers.

This money will only be used a match funding for the modernisation and repair scheme of the village hall
