Mr Knightley outlined the position with the fundraising for restoration of the village hall. £4K – Cllr Flitter from the Community Fund, £2K – DDDC grant, £2K from Tansley Development Association and have been given a legacy for £25K. The funding bid to WREN had been unsuccessful. Work on the toilet block and improvements to the entrance and roof all need to be carried out.

The Parish Council said that it was important to recognise that a fantastic sum of money has been raised by the village hall committee. The committee are worried that funds mights be recalled if they are not spent. There was some discussion over what the parish council should commit the previously agreed funding to.

### **RESOLVED:**

To commit the £10K to fund the project consisting of the toilet block and roofing works – Stage 1 of the whole project.
