There was some disappointment that the Council had been advised not to attend the meeting in May to discuss the proposed application.

Mr Raynes read out a letter to the meeting, about the Peak District Rural Housing Application for affordable homes on Thatchers Croft. Not opposed in general to affordable homes, but not at the expense of a green field site, why not build on a brown field site. Greenfield sites should be preserved unless there is an overwhelming desire that houses should be built there. There seems to be an inability to rent to local people, the planners should recognise alternative housing solutions. The rest of the field would one day be built on. Concerns about traffic safety, the amenities being on the other side of the A615.

Other residents expressed their views on the loss of ecological habitats, traffic safety, would ask that planners find alternative site or use existing properties or Drabbles Mill.
