107.2010.1 QUOTATIONS FOR NECESSARY WORKS

Steve Chapman spoke about the experience that he has had with various contractors over the years when dealing with the pitches.

Three companies have submitted quotations for carrying out necessary sanding works to the pitches, some of the companies have already carried out work and have met with the Football Club on site.

The contractors are Killingley of Chesterfield, D W Clark of Banbury, Pugh Lewis of Pilsley.

The quotations are as follows:

Killingley – rejuvenate all goal mouths, include seed and preparation, sand banding to both pitches price to include sand, machinery and site equipment, remedial works to pitches in the sum of **£4650**.

D W Clark – mobilisation of equipment to and from site, 400 kg fertiliser and weed spray, overseed with 100kg of rye grass seed, drag net 60 tonnes of top dressing sand into surface in the sum of **£4350**.

Pugh Lewis – weed spray all area, renovate goal mouths and centre circles with rootzone and reseed, supply 350 kg fertiliser, aerate pitches, supply and apply 50 tonne of topdressing sand, overseed with 200kg of rye grass, install sand bands in the sum of **£4412.50**

After much discussion about the work and the level of confidence in the contractors and their proximity to the pitches, it was

RESOLVED:

To award the contract to Pugh Lewis of Pilsley, the clerk would contact him regarding start date etc. Neighbours would be informed when the works would be carried out and the approximate length of time it would take.

107.2010.2 FUTURE EXPENDITURE OF THE FETE FIELD

Since the cost of the mowing would be considerably higher next season for the mowing of all of the pitches, quotations must be sought. Information was exchanged on how the Fete Field and the Pavilion was run, the ownership, publicity of the facilities and so on. Steve Chapman explained that the Fete Field has a committee made up of members of the Football Club, 1 Parish Council and others who oversee the running of it. The Parish Council owns the building and the land, and the football club pay for all of the running costs and minor repairs. The Parish Council arranges for the mowing of the pitches but is able to claim this back (at the present time) from Derbyshire Dales District Council.

Steve Chapman offered to make a presentation to Full Council next meeting, the offer was taken up.
