He wished to gain the Council's support for this initiative. The Council would support this, but thought needs to be given to the large financial outlay needed to get this off the ground.

82/2010 CORRESPONDENCE

82.2010.1 e mail from Mr Knightley regarding Quality Council Status The clerk read out the e mail asking that the council amend its practices, communications and composition to achieve Quality Council Status as defined by The National Association of Local Councils.

The clerk read out a response that had been sought through Derbyshire Dales District Council ' 1. Membership of the National Association of Local Councils is no obligatory, although members of the Derbyshire Associaton of local Councils would be recommended. 2. Minutes of meetings should record the names of councillors in attendance, minutes must be published within a reasonable time period and made available to the public. The Clerk is often the Proper Officer for the parish council's affairs and his/her name should be publicly available. The law relating to agenda and minutes, requires public access at the office of the Council which is usually the address of the Clerk. As most parish councils' have an electronic address, it is common for the minutes to be published in that way. 3. Councillors are elected to public office to represent the constituents within the parish not only those who may have voted for them. Whilst it is not a legal requirement to publish names and addresses on the internet the information should be publicly available.'

The parish council noted that there needs to be much improvement in the way that they communicate.

83/2010 PARISH COUNCIL WEB SITE

There was a discussion about the maintenance and improvement of the web site. Chris Knightley has offered to maintain the site (ie post information etc), which the clerk will send to him as appropriate.

Cllr Raynes said that the web site should be much better used to communicate, ie: the yearly precept should be on it, the income and expenditure of the council, the parish plan, parish council year end accounts and so on. Again, this included information regarding the membership of the council, none of the councillors' objected to their identities being put on the web site, phone numbers would be excluded.

RESOLVED:

That Mr Knightley's offer be taken up, he will maintain the site with information sent to him by the clerk. The precept, income/expenditure, parish plan, parish council year end accounts, councillors' identities would also be put on the site, the correct channel for contacting the council would be through the clerk.

84/2010 STREET SCENE UPDATES

84.2010.1. Dog Pooh Bins – 1 has been installed opposite Oak Tree Gardens, DDDC have run out of the posts for the bins, they have been reordered. The other two bins are to be sited on Spout Lane near to the village green and coming from the Coach Road onto Church Street.

84.2010.2 Litter Bin – the large free standing bin ordered has now been installed

84.2010.3 Enforcement Issues – Thatchers Lane- the clerk apologised enforcement action has not been taken against this person, however he has been requested by DDDC to clean up the site, and a caravan has already been removed.

84.2010.4 Overhanging Trees/vegetation – Cllr Raynes the issues of overhanging vegetation on the corner of Alders Lane which causes problems with the gully there. Cllr Strange raised the matter of overhanging vegetation on Church Street near Holly Lane (where the flagstones are). The clerk would contact Derbyshire County Council about both of these matters. There are also some overgrown free standing flower tubs in the village – the clerk would arrange for these to be cleared out.

84.2010.5 Noticeboards – the bid put into the Accessibility Partnership at Derbyshire County Council was unsuccessful. The provision of a new noticeboard was discussed. Jane Flanagan who lives near The Village Green has offered to put up/take down notices that can be left with her. Thanks go to her for that good offer.

84.2010.6 Blocked drains – a few of the drains have been blocked recently particularly at Church Street/Alders Lane – the Council have been in the village today unblocking most of the gulleys.
