# 4/2011 PUBLIC PARTICIPATION 4.2011.1 PUBLIC SPEAKING

- 1. Concerns were raised by a member of the public about the activities at 20 Riber View Close (drugs, noise, parking, dog mess and vehicle movements). Parish Council asked to invite police/environmental health to the next meeting. This issue needs MP involvement.
- 2. Problems with gullies on Daisy Bank, Alders Lane all blocked.
- 3. Lady asked to cut the hedge and remove litter at top of Fete Field, there are sticks with screws in top scream
- 4. Parking on Riber View Close and Mais Close is a problem

**RVC** -write to DCC highways to see if better parking places could be arranged; including the possibility of removing some grass verge from right hand side of corner.

**Mais Close** – Residents of Mais Close have found difficulty in gaining access to the bench closest to the Knoll, due to cars parking right up to it. This has caused aggravation between two elderly residents, and the household who use the bench area for parking their cars. This is apparently to avoid sap drips, not because there are insufficient parking places. – contact Dales Housing to arrange an on-site meeting to discuss a solution (which might include using a planter).

- 5. A property has been sold on Alders Lane there are now concerns about the possible loss of trees these possibly need a Tree Preservation Order.
- 6. **Nottingham Road planter** write to Tansley Garden Centre (Blue Diamond) to see if they would be prepared to carry on the annual maintenance of this.
