11/00626/OUT Erection 3 no industrial storage units and associated access (outline) at Unit 15-16 Brookfield Industrial Estate Tansley – no objections but slight concerns about the noise/disturbance that might eminate from these units and travels towards the neighbours across the road.

11/00563/FUL Material change of use and conversion of dwelling house into 2 no dwellings, erection of two storey extensions, formation of car parking areas and rebuilding of retaining wall at Two Ways Thatchers Lane Tansley – no objections BUT would ask that the extension is in stone, in keeping with the other properties on Thatchers Lane, and the Parish Council have serious reservations about the car parking, there should be a car parking area for the other property, there should be two car park spaces off the road for each property as they are three bed properties.
