- 1. A lady asked that a street light that has had its hanging basket bracket repaired, this has been damaged by youngsters. This would be reported. A letter would be sent to the community police regarding the problems with vandalism currently taking place in the village.
- 2. A gentleman spoke about the revised planning application for Thoresby, this had addressed some concerns, but he is still not pleased with this development.
- 3. A gentleman who lives on the edge of the village, asked a question about the refuse collection, Cllr Stevens tried to answer his questions. She praised the current refuse collection team. Thatchers Lane (10/00792/FUL) reprofiling of earth bund, work incomplete, wall not reinstated – query on original planning application – storage of agricultural equipment). The Wall has not been resinstated, work has not finished, there is a query over the storage of agricultural equipment, complaints have been received about noise emanating from there at all times and weekends.
