## 72/2013 PUBLIC PARTICIPATION 72.2013.1 PUBLIC SPEAKING

1. A lady from Thatchers Lane came to speak about the volume of traffic using Thatchers Lane and there is a speeding issue also.

The Parish Council have written to DCC previously about the need for signs i.e. caution children, horses, etc. Cllr Flitter reported that DCC are not happy about signs and are trying to remove the 'clutter'.

Cllr Raynes said there was an issue with people parking all day and getting lifts into Nottingham/Derby. The road crossing should go opposite The Tavern; Cllr Flitter would see Cllr Allsopp about this.

The Parish Council would write again to DCC and ask about ownership of the footway, the businesses should not be allowed to park so close to junction; there is no wish to impact on established businesses.

- 2. Cllr Stevens informed the meeting that the date for the Housing meeting is 20 November 2012.
- 3. Another lady commented that West Yard still looks such a mess. Cllr Raynes has spoke to DDDC and what the state of play is, is the play area available?, is it insured yet?, what about the road and street lighting? DDDC have informed the Parish Council that the matter is being handled by their Legal Team. The landscaping should be completed by end September.

The Parish Council would write again to DDDC; Head of Planning, copy to Chief Executive, DCC Highways and Peak District Rural Housing Ass.

Cllr Stevens would also chase the matter up.

## Feedback from DDDC Corporate Council Meeting

Cllr Strange had attended the meeting at DDDC on 13 September, there was some confusion regarding a big development. Cllr Strange was disappointed that the District Councillors had not spoken up about the history of the building.

DDDC would give the Parish Council a 25 year full repair and maintenance lease. The people running the building at the moment are response for everything to be done. The legalities of this type of lease needs to be looked at carefully as everything will need to be brought up to standard prior to any take over. Under the Landlords & Tenants Act the landlord has certain liabilities.

# 76.2013.2 Footpath maintenance, overhanging vegetation, suggested work before winter

The footpaths would be cleared again before winter, the shrubbed area near the village green can be tidied. The footpath at the rear of Tansley House Gardens needs to be inspected after the leaf fall, to see what needs to be completed, and then the Parish Council can write to the householders outlining their responsibilities etc.

The hedge at The Grove Church Street is giving cause for concern again regarding visibility.

The wall on Thatchers Lane/Alders Lane needs rebuilding and landscaping as this is part of the planning application.
