#### 80/2016 VENDING MACHINE

Mr Fox once more spoke about the availability of a larger unit, which would be provided on a six month trial and installed and operated at the company's cost. This unit would be unsuitable for the community hall as it would be too big. Location was still being considered for suitability.
