# 162/2016 PUBLIC PARTIPICATION 162.2016.1 PUBLIC SPEAKING

Glyn Jones of Y Bar Limited attended the meeting to speak about the proposed development at Tansley House Gardens.

Mr Jones had met with members of TPC 18 months ago, but there is now more land included within their plans. He presented an indicative plan of the site to be developed, there would be a pleasant amenity at the bottom end of the site, Ybar would be the lead developer. The road would be adopted from Church Street, and there would be agreements in place for this. There is outline planning approval already in place, and the development would be limited to 50 homes, due to highways matters. There is to be drainage engineers structural report to be commissioned.

There could be over 100 vehicle movements per day from the site, there is an online survey in connection with DDDC Local Plan, all residents need to comment on this.

There could be an issue with the footpath coming from Tinkers Bridge. Mr Jones said that one of the next stages was an engineering study, and there would also be negotiations regarding affordable houses. One of the members of the public wanted a village shop to be considered within the negotiations.

The suggestion of a village meeting was made, although there is a meeting at Highfields next week to discuss the matter with Derbyshire Dales, the village need to know how many houses? What the impact will be?. Whitelea may be coming forward any time now, and a further site might be coming forward also. DCC Highways need to carry out a traffic survey at peak times and they also need to share information and officers comments.

Mr Jones was thanked and he gave the offer of questions being raised directly with his company.

A gentleman raised the matter of flooding on Thatchers Lane, near Orchard House, the edge of the road is damaged due to the water, which has flooded into his garden. DCC have programmed some work to be carried out here.
