31/2017 PUBLIC PARTIPICATION 31.2017.1 PUBLIC SPEAKING

Members of the Public who had been present at the Local Plan meeting at DDDC thanked DDDCllr Steve Flitter for speaking on Tansley's behalf at the meeting. Clarification was sought on the 96 (how was it small scale) properties in Tansley and the Parish Council's stance on these, there would be 49 on Tansley House Gardens, 27 at Whitelea, these would impinge on traffic movements, and the drainage systems. The development at Gritstone Road would also affect Tansley.

**Hannah and Rob from National Grid** were welcomed to the meeting and spoke about the works to be carried out to the gas main, the road would be closed on 30 August 2016 possibly for up to six weeks, the closures would only be implemented if absolutely necessary, wherever possible the service and the access would remain open.

There were questions put to the two representatives of National Grid about the works.

The Parish Council thanked them for attending and confirmed that information would be put on Hotwire about the works and contact details.

The discussion about development resumed; Cllr Raynes reported that when the planning application for Tansley House Gardens every planning point has been put on hotwire for residents to put forward to DDDC. Now the developer has put in for a full application for 49 dwellings, and there would be no benefit to the village, i.e. no play area, also the Whitelea developer is not planning to benefit the village. The Whitelea site has gone into the local plan very recently although as yet no planning application has been received. There is also a site at Jackhill for 48. Tansley Parish Council has been trying to get the settlement framework boundary firmed up, and DDDC has finally agreed to this.

The Parish Council has got to make representations about the plan, some of the sites put forward will come out of the plan if the site is considered to be unsuitable. A lady spoke about Whitworth hospital and the fact that it may be losing some of its bed provision, she wished the Parish Council to write against this. The Parish Council would write against these moves.
