183.2016.4 LOCAL PLAN

Need to respond to DDDC about the four sites; Tansley House Gardens, Whitelea Lane, Jackhill and Thatchers Croft.

The sites need to be:

Proportional to the side of the village, too many proposed for a small village, Proportional to other settlements,

What are the numbers for Tansley,

Small developments, not large estates,

Limited infrastructure – what would be the benefits to the village.

Development is not sustainable there isn't a shop, doctors, bus service in decline;

There is no confidence in the numbers in the local plan and what will finally be achieved through the plan.

A letter would also be sent to YBAR of Chesterfield, regarding the development of Tansley House Gardens, the parish council vehemently oppose any more development on the site, and are disappointed that he had not fulfilled the gentlemans agreement. The parish council would like to be involved in the development of the 27 properties, and would like further discussions, as there is no play area, and not the required number of social housing, the footpath should be maintained as agreed. There is concern about the location of properties at the industrial estate end of the site regarding the noise, this ought to be screened by trees, the holding pond needs some sustainable drainage included.
