# **75.2017.1** Planning Applications for Consideration:

## Cllr Woods explained a bit about the application and left the building.

**16/00779/FUL** Erection of three dwellings and associated garages Land adjacent to 9 Oak Tree Gardens Tansley Derbyshire - the applicant explained about the changes that have evolved through discussion with DDDC planners' since outline planning was granted in 2014. An extensive discussion was held about this application.

#### **RESOLVED:**

OBJECT- against outline application, not in keeping with the area, is contrary to condition 3, too overlooking and to prominent, the construction materials are significantly different (should be in stone) are out of keeping and do not reflect the character of Tansley.

The flood team did not think the outline planning application had enough information

Concerns about spoiling the setting of Grade 2 listed properties, must adhere to the heights of properties as stated in outline condition and Overlooking of the listed buildings.

**16/00786/FUL** Two storey side extension at Green Gates, Alfreton Road, Tansley – no objections

**16/00397/FUL** Amended plan Residential Development 49 dwellings and associated garages and infrastructure at Land at Tansley House Gardens
