PLANNING MATTERS 137/2017

137.2017.1 Planning Applications for Consideration:

17/00243/CLPLUD Certificate of lawful proposed development - erection of outbuilding at The Willows Church Street, Tansley – no comments/objections 17/00232/FUL Extension of outbuilding - Overcliffe Church Street, Tansley unanimous objection as follows: too large out of keeping, it appears larger than the footprint of the house, overdevelopment of the garden, loss of amenity for adjacent residencies, very close to a public footpath (security issues), overlooking close to the proposed development of Tansley House Gardens, concerns over access, should the planners think it wise to pass this,

the building must not be sold separately and should always be ancillary to the main dwelling.

17/00197/FUL Single storey rear extension - Red Hill House, Red Hill, Tansley – no objections, very pleased it has a slate roof and is in stone in keeping with the vernacular.

17/00107/PDA Change of use of of agricultural building to dwelling house(s) (Use Class C3) and associated building operations – The Barn Alders Lane Tansley – comments as follows: west elevation – should not have windows as overlooks private garden, north elevation – should not have windows as it is overlooking The Orchard or the highway. Windows should be installed as this will help to retain the integrity of the agricultural barn on the skyline.
