65.2018.1 Planning Applications for Consideration:

17/00827/FUL Single/two storey extensions and detached garage at Lane End House, Green Lane, Tansley – object, as it not constructed wholly in stone, the

village is losing a lot of the stone built properties, and the roof should be slate and not zinc, the garage that is adjacent to the Fete Field spoils the aspect.

17/00811/FUL Retention of garden decking and summerhouse at 1 Hill Top Terrace Alfreton Road The Cliff Tansley – no comment

17/00454/DCOND Discharge of Condition 2 at Croft House, Nottingham Road, Tansley – comments are regarding the tipping of the spoil, is the vehicle being used licensed, as there does not appear to be a licence plate on it.

17/00878/FUL Proposed rear extension at Scotland Villa Stretton Road Tansley – no comment

17/00850/FUL Erection of 27 dwellings and widening of existing access to serve development and retained property on site at Land off Whitelea Lane Tansley - strongly object - a section 106 should be used for upgrading the facilities in the parish and not in other areas. Davis Homes do not want to put in a play area and have said that they would upgrade the existing. DDDC have said that there could be an off site commuted sum which would go to public open spaces.

There has not been a transport survey carried out. The developer has said that they would remove the conifers on the edge of the site. The planning application shows 6×1 bedroom houses and not bungalows as required by the village. There is an attenuation pond at the top of Green Lane. This application is contradictory to National Planning Policy Framework.

DDDCllrs seem to be protecting their own areas, and say that it is the government's fault when the blame seems to fall on DDDC.

The Parish Council had asked the Inspector to remove the site as it was now no longer necessary. Since this application was first instigated, Tansley House Gardens site has doubled in size. The transport network will not stand another 27 dwellings on the top of Tansley House Garden numbers,
