# **17/01154/VCOND** Variation of Condition 2 of 16/00641/FUL to allow for the housing of agricultural livestock as well as horses and ponies in stable building.

-. Does the application relate to the whole of the stabling buildings or part - you will remember the buildings went up piecemeal. How much land is attached to the stabling. We are confident in the

knowledge that buildings housing livestock need drainage there is no mention of this in the application, there is also no mention of the removal of effluent.

Has the land got its own water supply? we believe the above are necessary for the safe husbandry of livestock.

# 107.2018.3 Planning Issues 107.2018.3.1 The Gate Inn

The top entrance on the first planning application was noted and on the subsequent one it was not noted. DCC did not assess the sightlines on the top entrance – it needs better sightlines and there are no splays, it would be better to go in the top entrance and come out of the bottom. It is probably safer to have two opening and the splays improved to highway standards.

Cllr Strange did not take part in the discussion below:

#### 107.2018.3.2 The Coach Road

Work started on this building a long time ago, the base has been down for many years. This was granted planning permission years ago, and more recently building regulations as work has commenced again. It is understood that if work has started then no further planning permission is required.

To write to John Bradbury and ask that the Parish Council are appraised of the situation on both of the above planning issues.

Cllr Strange rejoined the meeting.

# 109/2018 ENVIRONMENTAL ISSUES 109.2018.1 Play Area Village Green

Councillors had met with a representative of DDDC in November, and are still awaiting the quotes despite trying to follow these up. The matting on the play area has been cleaned and looks much better.

# 109.2018.2 DCC - Delivery of Salt and Snow Wardens Request

The salt has been received and more snow wardens than ever have come forward. Cllr Strange would make arrangements to deliver more salt.

#### 109.2018.3 The Pinfold Thatchers Lane

The Parish Council have contacted DDDC about this piece of land, and they have been informed that it has been included in the land review which is currently taking place.

#### 109.2018.4 Alders Lane – constant water flow from Thatchers Lane

There is a constant water flow from further up Thatchers Lane, apparently this is water flow from the fields going up towards Riber. All of the gulleys on Alders Lane require cleaning.

#### **RESOLVED:**

To request a copy of the gulley cleaning schedule from DCC Highways.

#### 109.2018.5 Thatchers Lane - Road and Ditch

Below the junction with Alders Lane a ditch has been dug within the verge on the highway, this could be quite dangerous to passing traffic. It has been coned off for the time being.
