37.2019.3 Planning Issues

The situation regarding the development at Whitelea Lane and Community Infrastructure Levy was discussed. DDDC have asked the developer for £500 per unit, the house numbers is now 26 (£13K), this would only be payable when the first resident has moved in. DDDC also has £13K for sports capital which could be for drainage of sports pitches, there is also £8,500 to be put on one side for further works.

Healthcare – Section 106/Community Infrastructure Levy – there has recently been an article in the Matlock Mercury, the Clinical Commissioning Group is only consulted on developments of 50 or more units, there is to be 49 on Tansley House Gardens, 26 Whitelea. The Doctors surgery are stretched already with long waiting times for appointments.
