#### 94/2019 PLANNING MATTERS

## 94.2019.1 Planning Applications for Consideration:

18/01220/CLPUD Certificate of Lawful Development at Mooorcroft Alders Lane Tansley – no objections

18/01175/FUL Conversion of building to dwellinghouse (C3 use). Demolition of adjoining agricultural building and erection of detached garage – object as

follows: unable to tell from the plans what the materials are, the drawings appear to be only indicative and not pertinent to the application, giving no perspective of how this will be viewed from the wider community, if DDDC decide in favour, then it should be 'tied to the farm' with an agricultural tie, and not be a stand alone dwelling house.

18/01144/FUL Erection of a lamp post to illuminate access path at Holy Trinity Church, Church Street, Tansley – no objections

17/00627/DCOND Discharge of Conditions 1,2,3,4 and 5 at Land at Junction of Cunnery Lane and Alders Lane – write to DDDC asking that they get the site address correct, and ask for clarification of where the soil will be spread.

#### 94.2019.3 Planning Issues:

## 94.2019.3.1 Whitelea Development

Whitelea Development – a resident has been in touch with the Parish Council regarding the vehicle movement in/out of the site each day, each vehicle will shine their lighting onto the property. The developer has offered to build a wall to shield this. If the developer used the second entrance this would not be an issue.

There are also concerns about the potential flooding issues, TPC have been in touch with the Flood Team, there are also problems with the hedge, health & safety checks, use of render, the roadway next to the playing fields, and the sough.

#### **RESOLVED:**

To write to DDDC and a separate letter to DCC Highways.

#### 94.2019.3.2 Section 106 Old Coach Road

DDDC are wishing to cancel the debt, there is owing in the region of £59K, they appears to be no possibility of recouping the debt and they are wanting to write this off. Liquidation process of Barncroft Homes is currently going through.

## **RESOLVED:**

That Members of the Parish Council would attend the meeting at DDDC and speak about the writing off of the debt and how Tansley will lose out because of the loss of the money.

## 94.2019.3.3 7 The Rocks Tansley

A porch has been constructed to the property and the house has been rendered.

#### **RESOLVED:**

To write to DDDC regarding the construction of the porch and the fact that the property has been rendered.

## 95/2019 SCHOOL BUS, WALKING ROUTES

Cllr Burfoot arranged a walk with Angela Goodall to the Coach Road. Cllr Lane spoke about the number of children (between 14 and 20) who get on at The Tavern, and how they actually get there to get on the bus, some parts of the village are outside of the 3mile limit, this depends where it is measured from. The footway is often single file, the Coach Road is unsafe. DCC are going to do a traffic count.

## **RESOLVED:**

That thanks go to Cllr Lane for his work on this. DCCllrs are going to also do the walking route, there is also to be a traffic count in the new year.

#### **96/2019 FETE FIELD**

The work has been completed to a very high standard, the stream is flowing well, the gate is now on. All of the residents that were involved were very responsive to any request regarding vehicles, clear way for contractor vehicles etc. Thanks must be given to all residents of Green Lane and Masson Terrace for their co-operation.

RESOLVED: To make payment for the work, including a letter stating that the Parish Council are very pleased with the work and the condition of the site on leaving.

A resident of the new houses keeps advising the contractors on where and when they can park, then another trade will turn up and then the process begins again. There seems to be little that can be done except for keep advising the contractors as and when.
