#### 162/2019 PUBLIC PARTIPICATION 162.2019.1 PUBLIC SPEAKING

#### 165/2019 COMMUNITY HALL

Committee Meeting last week, funds are now quite healthy at around £9K. Some money has gone into their reserve account to be able to demonstrate match funding when making grant applications. Progress is also being made on the Toilets. The AGM will be in July, the roof has been repaired, this was facilitated by Cllr Strange. Cllr Strange also informed the meeting that the roof would soon need to be replaced. The Parish Council would fund this recent repair.

## **166/2019 PLANNING MATTERS 166.2019.1 Planning Applications for Consideration:**

**19/00231/FUL** Conversion of barn to habitable space with a glazed link extension to main dwellinghouse at Glebe Farm Church Street Tansley DE4 5FE **RESOLVED:**to object to the application in its current form, however, if amendments were made as follows: the wood cladding should be replaced with stone, as it in not in keeping with the vernacula, the roof lights should not be visible from Church Street, could these be on the other elevation?,the window in the apex is too visible from Church Street, and should be more traditional style?, all vehicles that access the site must exit the site in forward gear, **19/00342/ADV** Retention of replacement signage at The Gate Inn The Knoll Tansley

**RESOLVED:** the position of the new vehicular access enables the recommended emerging visibility splay of 2.4mx 43m to be achieved in the critical direction (to the south). Whilst the emerging visibility to the north east would remain substandard, the location of the new access is a significant improvement compared with the existing layout, therefore a highway objection on substandard emerging visibility in the non-critical direction alone is likely to be sustainable.

Before any other operations are commenced (excluding Condition No1 above) a new vehicular access shall be created to Whitelea Lane in accordance with the application drawings, laid out, constructed and provided with a visibility splay of 2.4m x 43m to the south, the area in advance of the sightlines being maintained throughout the life of the development clear of any object greater than 1m in height (0.6m in the case of vegetation) relative to the adjoining nearside carriageway channel level.

While the Parish Council are very happy with the signs that are on the front of the building and also the tall sign, it is the 'A Board' style of signage that is giving them cause for concern, these boards appear to be blocking the sightlines due to their considerable size.

understood that the green field is being gardened and parked on, the planning application at this site shows a turntable which we understand may not be put in. This was discussed at length and it was

# **RESOLVED:**

To write to DCC Rights of Way and ask that they request the steps be removed as they are an extra hazard. To write to DDDC Planners querying the gardened area, turntable and parking outside of the site.

**The Ropewalk** – this has recently had a large bonfire to the side of it, which was nearly getting out of hand, there were children around as it was the school holidays and apparently the gentleman who lit the fire became abusive when remonstrated with.

**RESOLVED:** To write to DDDC Env Health and DCC Rights of Way regarding these issues.

Emails have been received from DDDC with the offer of the Pinfold to the Parish Council. DDDC did not anticipate the transfer costing more than £350. **RESOLVED:** That the Parish Council continue to pursue getting The Pinfold back for the village.
