# 26.2021.1 STWA - feedback regarding drainage issues

The flooding problems near South View – a camera had been put down the drain, and it appears that a 'trap' had been installed incorrectly, and the water leak outside Cllr Raynes property had been resurfaced but the work was not satisfactory.

# **26.2021.2 The Cunnery – Litter Issues**

Amber Valley Borough Council has been asked to provide a litter bin at this location.

# **26.2021.3 DDDC – Weed spraying consultation**

Consultation has been received from DDDC on whether weed spraying is required in the village in the future.

**RESOLVED:** That the Parish Council would like the District Council to continue with their weed spraying programme.

# **26.2021.4 Allotments**

There have been quite a few responses requesting allotments, now possible sites need to be discussed.

**RESOLVED:** To approach the initial contacts and ask if they would help facilitating this to move forward with this matter.

#### 27/2021 HIGHWAY ISSUES

#### 27.2021.1 The Knoll - Condition of highway

The condition of the highway is very uneven from Holmesfield Close to the junction with Oaksedge Lane.

**RESOLVED:** To write to DCC Highways requesting they carry out repairs.

27.2021.2 A615 - Jackhill to Garden Centre (dangerous surface/overhanging vegetation

**RESOLVED:** To contact DCC to have a look at the concerns regarding the surface of the footway.
