The water connection for 11 properties is at the top of the path, the others are to be connected into Thatchers Croft The developer confirmed that he had spoken to some residents regarding the works. The road closure also covers the work to have the sone wall rebuilt also. The site security fencing would be moved to allow works to be carried out.
