#### 34/2023 COMMUNITY HALL-

**34.2023.1 Work to the Windows** – two quotes have been received for replacement windows; D M Stanley £9300 no detailed specification received, CMC £9,235 a detailed specification received. To ensure that the price is fixed and not subject to a high increase which is anticipated, a quote needs to be accepted as this point to ensure the price.

#### **RESOLVED:**

That the quote for the windows be accepted from CMC. The community hall are loaning the parish council £10K, which will be repaid.

**34.2023.2 Work to the roof** has started and Cllr Strange would enquire as to progress. Cllr Taylor informed the meeting that the contractor wished to install an outside tap at the back for their use (at their cost) this met with no objections as long as there is the ability to turn off within the building.

The other piece of lane is on Coach Road and this is landlocked. Cllr Raynes is to attend the meeting at DDDC tomorrow evening and the neighbours have been alerted to these sites.

#### **36.2023.2 Village Green Picnic Table**

This needs fixing in place, Cllrs Smith & Toplis agreed to do this, and would fix on a base with some pavers on top to ensure that it looks in keeping with the surroundings.

#### 36.2023.3 Allotments

Cllr Strange would make initial enquiries regarding the suitability and availability of a piece of land near to the Woodall Homes site.

There is also water coming up through the footway on the Woodall Homes site, and there is a query over the condition of the Highway also.
